Initiative Updates

- <u>I-64 Gap Project</u>: VDOT's grant application has received \$25M. VDOT is moving ahead with construction.
- <u>Walk/Bike Trails</u>: \$93M is available for Virginia trails, with \$3M dedicated to a new trails' office. Although a law to fund a certain number of trails has passed, the BoAT and Fall Line Trail were not specifically mentioned. The next step is to explore how to include these trails in the budget, given the funding criteria. A definitive plan will be created once a new head of office is hired.
- <u>Global Internet Hub Strategic Plan Initiative</u>: The final Steering Committee meeting is scheduled for Tuesday, February 28 and will include the final reports from TeleGeography and InterGlobix about other Global Internet Hubs and where we stand. An emerging strategies discussion will be held by the Steering Committee. The resulting report and map will be reviewed by the EC prior to its release.

This initiative's economic development impact goes beyond the megaregion throughout the state of Virginia. Support from the state and localities will be indispensable. The future of this initiative could morph into something new, like an independent entity.

• <u>Passenger Rail</u>: There are no updates at this time.

Committee Reports

- <u>Nominations & Governance</u>: New directors of the board were voted in. Current changes to the bylaws are on hold but are queued up for additional changes down the line.
- <u>MIC</u>: The co-chairs are coordinating catch-up meetings with their regional MIC members. These meetings will provide an opportunity to clarify the intent and purpose of the MIC and explore the benefits of collaborating with our organization.
- <u>Development</u>: The first quarter of 2023 emphasizes a need to follow up on pledge renewals. Financial commitment forms will be sent along with invoices for all upcoming pledge renewals. The committee will be ready to provide reminder phone calls when requested by Laura Robidoux.

Another goal is to explore new sources of funding to support specific initiatives, such as university foundations or outside grants. An annual meeting for higher education leaders may increase engagement and find complementary initiatives and activities that are appropriate for university investment.

Funders will be contacted and thanked in appreciation for their support of RVA757 Connects' organization and priorities. They are the root of our organization's success.



Creating a branding piece, such as a cardstock overview, will provide a clear, concise, and consistent message. A book containing directors' bios is in the process of being constructed.

The Virtual Innovation Spotlight webinar provides a general demonstration of what's happening in the community. It's completely unique programming. Greg will provide participation and engagement data at a later meeting. The next goal is to increase engagement.
