#### **Quick Updates**

Joint Chamber ICV Trip – John Martin informed everyone this would not happen this year. However, it's likely to happen next year.

School of Public Health – John Martin informed everyone that this is currently on hold. We have reached out to President Rao and reiterated our support for and assistance in advancing this topic.

Head Start on The Biden Infrastructure Bill – Jim Spore and Tom Frantz brought everyone up to date on Hampton Roads' efforts to get into the best possible position to advocate for greater investment in Hampton Roads' infrastructure. This includes teaming up with the Richmond region on projects that will benefit the megaregion, including RVA757 Connects' priority areas: I-64 gap funding, increased passenger rail, advancing the Richmond port, and advancing the I-64 Innovation Corridor. The Executive Committee approved John Martin reaching out to the appropriate officials in the Richmond region to explore this potential partnership.

#### Old Business / New Business

John Martin informed the Executive Committee that the next several Executive Committee meetings will include a deep dive into RVA757 Connects' Communications and Action Plans related to priority focus areas.
