The "TBD Pledges" (our best guess estimated amounts) total \$60K. These are from leaders of large organizations who are committed but who are relatively new board members. This \$60K total estimate at worst case could be \$30K.

The "Potential Pledges" are potential new members that we are in conversation with about either joining or re-committing to us —See below. This group could represent an additional \$30K, making up the worst-case scenario (\$30K) from TBD Pledges. Potential Pledges are not included in the above chart.
