Approve January 12th Executive Committee Minutes

The Executive Committee (EC) unanimously approved the January 12th EC meeting minutes.

Government Relations - Direction for RVA757 Connects

Ross Grogg and Christopher Lloyd provided updates from the General Assembly, which is in its third week of the 2022 session.

The updates focused on topics that require support and ongoing attention from RVA757 Connects:

 A total of \$180M has been slotted for megasite development by Northam and Youngkin. Historically, Virginia has been overlooked by businesses attracted to megasites in other regions, such as North Carolina, Ohio, and Georgia. VEDP will lead site developments and draft guidelines for funding allocations.





- 2) Additional funding is going toward GO Virginia for talent retention efforts, aligning the business community with education.
- 3) Investments are being made in Hampton Roads for coastal resiliency, including a coastal mapping plan and climate resiliency funding. The Coastal Virginia Resiliency Authority has been established for larger projects. A revolving loan fund will be available for smaller resiliency projects. Resiliency is being proposed to become a component of SMARTSCALE project measurements.
- 4) The increase in fuel and gas taxes is delayed for one year. Projections show approximately \$1.5B in transportation revenues, along with \$1.1B expected from the federal infrastructure bill.
- 5) With the FY21 surplus, Northam proposed \$20M for the I-64 Gap Widening and \$40M for I-464.
- 6) GO Virginia is supporting workforce development studies, such as a proposed JLARC study. Hampton Roads' offshore wind industry is a strong example of workforce development efforts. It addresses wraparound services (childcare, transportation, etc.) and navigates the region to seek out underemployed communities.
- 7) Misc. Items:
 - Jefferson Lab Planning funds for a high-performance supercomputing data facility.
 - Hampton Roads Alliance Proposal for supply chain grant funding.
 - Port of Virginia Language to authorize the port to issue debt and project funding.
 - Virginia Community College System New chancellor will be selected.

How RVA757 Connects Can Help Moving Forward

The caucus from HR and RVA should work together. Individual contacts will be best way to start for 2022.

In 2023, a policy agenda should be identified and published with 5-6 items that support the growth of the I-64 Innovation Corridor. This agenda will be used as talking points in being proactive versus reactive.

Letters of support at the federal level will be helpful for initiatives, such as the VNG pipeline.

Legislative champions to consider include: Mamie Locke; L. Louise Lucas; Ryan T. McDougle; Jennifer L. McClellan; Delores McQuinn; and Glenn Davis.

Next Steps:

John Martin and Laura Robidoux will put together a Government Relations PowerPoint deck for Chris Llyod and Ross Grogg to present at the March 22 Board/MIC meeting.
