Approve April 28th EC Minutes

The Executive Committee (EC) unanimously approved the April 28th EC meeting minutes.

Nominations Committee Update

The Executive Committee finalized the list of candidate directors and discussed the best methods for recruitment. An EC member was assigned to each target.

It was agreed the Development Committee materials will be a useful asset when recruiting for the Board, as being a Director carries a financial responsibility as well.

Discussion Considerations:

- Not all CEOs will be able to dedicate time to our organization. In this case, we will ask them to
 point to recommended leaders within their organization. These individuals may be emerging
 leaders who may also help us achieve our goal of being a diverse board.
- Having an in-person (Zoom) meeting versus a phone call will depend on each individual's
 relationship to the nominee. New people should participate in a Zoom meeting with one or two
 EC members.





- The fundraising ask will become a part of the nomination presentation. Development Materials will be used for this portion of the discussion. In its second phase, our website (www.rva757connects.com) will become a more dynamic source of information for nominees.
- It was agreed for all candidate directors to be approach before June 9th (next full Board/MIC meeting) so we can report on our progress.
- It was also agreed to schedule an "Orientation Meeting" prior to the Board meeting. Possible dates were discussed.
